Councillor Mrs Stella Abbey reported: - "A Life in the Year" on the 29<sup>th</sup> went extremely well. Tickets are on sale for the New Years Eve party.

# 1595 HIGHWAYS

The meeting wit Colin Fletcher was very productive, the following action was agreed and should be implemented by the end of this financial yaer:-

- Two monitoring kits will be fitted, one on the Church site of Court St and the other
  on the up side of Bakersfield. These will give a record of traffic volume & speed,
  good for future reference.
- 2) The yellow hatched box outside the Jubilee Hall will be extended by two kerb lengths in a northerly direction to improve access for Manor Cottage No 4 Church St.
- 3) The white line at the junction of Church St & Fore St will be extended around onto Church St to improve visibility by advising no parking on the junction.
- 4) There will be a shadow footpath along Western Way by the wall of Post Office House to a point opposite the War Memorial steps.
- 5) County will move the 30 MPH signs, on the northern approach to the village, towards the open area near the allotments, improving their visibility.
- 6) There will bee new 30 MPH signs on the Western approach (Western Way) and the Eastern approach (High St & Crewkerne Hill). These signs to have the words WINSHAM on them. There are at present no village name signs on the easterly & westerly approaches.
- 7) There will be 30 MPH markings on the carriageways, north, south, east & west, to help slow down traffic.
- 8) The school sign on Western Way near Bolsom Close will be tightened.
- 9) There will be improved signage at the bend near Whatley Cross.

- c) Mobile Phone Mast in Church Tower. Whilst not opposing the proposal in principle the PC has some concerns over the proximity of the mast to the school. The PC's preferred siting of a mast would be on the Upper Recreation Ground. They appreciate that the Church is looking for an income and suggest that the revenue from a mast on the Upper recreation Ground could be diverted to the churc restoration project for an agreed period of time.
- d) Wording on Dennis Shaw's memorial plaque was agreed.
- e) The Clerk has written to Hastoe about weeds.
