**1760 DISTRICT & COUNTY COUNCIL MATTERS**

Councillor Robin Munday – reported the Joint Area Committee is still pressing forward and agreeing terms.

The District Council needs to decrease expenditure in some areas. There are some areas where they are obliged to spend considerable sums such as free bus passes where there is a large shortfall from government to meet this areas need. They are currently going through a process of ‘lean thinking’ and streamlining departments to improve internal efficiency.

The site for the Sports Zone in Yeovil has been explored but it has not been designed yet.

Councillor Stella Abbey asked whether the Development Line still stands. Councillor Robin Munday replied that it did with the exception of Housing Association requirements.

Councillor Roger Beer asked if councils were willing to take on roles from the District Council following the Devolution Survey. Councillor Robin Munday replied that larger town councils will probably take on extra responsibilities but will need funding from the District and County councils and this will be a debating point. He felt that a good example of where smaller parishes might like to step in is; grass cutting contracts and footpath maintenance, currently the District Council spends more money than allocated by County Council to this cause but this may be an area of future cuts backs.

Councillor Tony Shire reported that budgeting was also on the agenda for County and they need to make further savings. They have been working on budgets for the past 4 months and have made efficiency savings.

County’s part of the Area Committee panel could be happening as early as February or March. The Parish member will be able to input on policy matters but not individual cases.

The Area committee should give the public an increased opportunity to have their say.

Councillor John Gapper asked if there were cost implications to the Joint Area Committee.

Councillor Tony Shire replied that it is something that will have to be monitored.

The Taunton Park and Ride on the east side of town is due to start in 3 months and be completed by October 09.

Councillor Trish Baxter asked about pavements and right of way. Councillor Tony Shire explained that someone may own the subsoil but there are highway rights over them so that the owner has no more rights than anyone else.

### **1765 AMENITIES**

- a) Councillor Andrew Partridge reported that the Chicken is still in need of repair. Councillor Peter Harper maybe able to repair it over the winter but might need some help.
- b) The Parish Council decided that the surfacing under the slide was the next most important area to be tackled. The equipment will also need painting again and there still remains the issue of fencing following the risk assessment. Councillor Andrew Partridge commented that a solid fence may restrict the view from cars at the crossroads and therefore maybe a safety concern. There was also a discussion on effective signs and which activities should be restricted (currently ball games, cycling and dogs) – *Action Clerk to investigate fencing, legal issues concerning signs.*

Councillor John Gapper has walked and cleared styles and gates where he can and reported 3 things to County. He asked that if anyone notices anything please let him know.

Councillor Peter Harper commented that the new sign post at Rose Lane had disappeared again. *Action – Councillor John Gapper to report it.*

Councillor Mary Haggard expressed concern that parents dropping their children to school and preschool, park up on the pavement just before the junction making it impossible for anyone with a wheelchair, push chair or mobility aid to get by. Councillor Stella Abbey responded that this was probably an issue to be taken up by the school.
