1836 DISTRICT & COUNTY COUNCIL MATTERS

Councillor Tony Shire asked whether there were any questions from the Parish council. Councillor Trish Baxter asked were to send the information on the poor bus service. Councillor Tony Shire recommended forwarding it to him.

Councillor Roger Beer asked whether the speed monitoring had been completed as two black boxes had appeared but no cables over the road. He also asked that if the readings were taken in the school holidays would the data be adjusted to reflect this. Councillor Tony Shire reported that they may have been laser boxes and that data would be adjusted.

Councillor Robin Munday asked about the 20mph speed limit policy from central government. Councillor Tony Shire responded that County had not yet received ant information from central government on this issue. He went on to report that Highways have now looked at speed limits for accident hot spots and are currently looking at areas with occasional accidents.

Councillor Robin Munday reported that there are a few matters on hold pending the County elections on June 4^{th} . Through the Joint Area committees District are learning about some of County's operations, e.g. Highways Maintenance. The next presentation is from Social Services on the 20^{th} June.

Councillor Kim Turner commented that Joint Area committees are making contacts between District and county easier. They would like Parish councillors to attend. Kim then asked if there were any questions.

Councillor Stella Abbey asked why there were so few planning applications going to committee. Councillor Kim Turner responded that there were fewer applications going through probably due to the economic climate and also due to the process management and performer.
