1889 <u>DISTRICT & COUNTY COUNCIL MATTERS</u>

Councillor Robin Munday reported that the Chief Executive is David Taylor in the interim. He also reported on a meeting with the bus company about recent problems and the new arrangements, the company were not planning on making any changes. Winsham's questions were aired. The County have their own inspectors and will be monitoring the service. Winsham will have its own mystery traveller.

The County council have seized £200,000 worth of counterfeit goods.
