## 2109 DISTRICT & COUNTY COUNCIL MATTERS

Councillor Robin Munday reported that finance was still the priority at the moment. The projections and preparations they have made have stood them in good stead following the recent government review. Highways will have a very tight budget and there is no resurfacing planned at all. The community safety budget is cut and it will mean that 10 or 12 PSCOs will go. Art council has gone and youth clubs have been reduced by 50% and will be only statutory. The county Councils are having a difficult time cutting spending. Councillor Trish Baxter commented that in the long run it maybe beneficial to have this review of spending and staffing.

Councillor Robin Munday continued – The East Devon partnership is still going forward however the staffing structure is to be looked at again as East Devon have more management posts and therefore will need to do some lean thinking before there can be a joint management.

Councillor Peter Harper commented that highways are facing big cuts yet they have just resurfaced the A30 by Cricket and have put in an excessive amount of new gulleys. Councillor Trish Baxter asked whether the Parish Council could write to someone to support our current PCSO.

- b) The draft precept was debated, the main area of expense is the grass cutting, a discussion was then held on the value of keeping the church yard neat or whether we could accept a lower service, problems may then arise that each cut is then more difficult and that this then maybe a less economical way to cut the grass. Some villages do depend on volunteers but it was felt that this was not a suitable solution. The draft precept was agreed. Action: clerk to finalise the precept and Councillor John Gapper will inspect the accounts with the clerk to ensure transparency.
- c) The Council agreed to the SSDC doing the playground inspection next year. *Action: Clerk to submit form.*
- d) There has been a rebate from the Council for the cemetery rates as we are classed as a small business. The clerk is unsure whether this will happen next year.
