# 2159 PUBLIC QUESTION TIME

## 2160 DISTRICT & COUNTY COUNCIL MATTERS

Councillor Kim Turner reported that South Somerset had agreed the budget and were now looking at the next financial year. There are going to be cuts in the bus services especially Sunday services. Councillor Kim Turner expressed her concern that County had not consulted children when they planned their cuts to services, the United Nations Article 12 children, which was adopted by the Council, states that they must be consulted, also there are concerns about the lack of quality and diversity considerations. Area West are planning to write to County about these concerns.

A discussion followed about consulting children in matters such as transport and libraries and whether their views should be taken into account. Varying views were expressed.

There have been 26,000 signatures against the closure of libraries. Consultation papers are out now. The mobile buses have been cut from 6 to 2; the impact on Winsham is as yet unclear.

Two small schools are set to close, Winsham remains safe.

There has been fencing and cabins placed in the Chard Show ground, it is unclear if they have planning consent. This matter was brought to the attention of Councillor Kim Turner by a member of the public and therefore she will investigate matters.

Councillor John Gapper asked whether reports from County are given non-politically or whether councillors own political views are represented. Councillor Kim Turner reassured the Council that reports are given in a non political manner.

Andrew Partridge declared an interest in item 10b.

**2162** MINUTES OF THE ORDINARY PARISH MEETING held on 2nd February 2011. The Chairman signed the minutes as a true record.

# 2163 <u>MATTERS ARISING FROM THESE MINUTES NOT COVERED</u> ELSEWHERE AND ANY SUBSEQUENT ACTION TAKEN

- a) The clerk informed the Council that the application forms for the Parish Council elections had now arrived.
- b) Councillor Stella Abbey asked whether volunteers could clean the war memorial

inscriptions. The clerk responded that insurance did cover volunteers. *Action: Councillor Stella Abbey to organise volunteers.* Councillor Stella Abbey continued to inform the Parish Council that St Marys in Chard had quotes from £650 - £1350 to renew their inscriptions. Councillor John Gapper has also asked Thorncombe about their tenders for their Memorial. Their project is being run by the British Legion rather than the Parish Council. He added that the information he had received implied that there was no great urgency to clean the memorial and that warnings were given about doing more harm than good.
