031 PUBLIC QUESTION TIME

Messrs. Marsh and Smart from the Sports and Social Club produced plans drawn up in March 1998 for a new Sports and Social Club.

To facilitate a lottery grant it was felt a 99 year lease on the land would enhance the application. This to be discussed by the Parish Council in October.

Costings for the larger building which would allow for a badminton court would be in the region of £300,000 for a smaller building it would be £250,000.

The Sports Council at the present time would fund 85% of the building costs.

032 MINUTES OF THE ORDINARY PARISH COUNCIL MEETING HELD ON 1st JULY 1998

033 MATTERS ARISING FROM THESE MINUTES NOT COVERED ELSEWHERE AND ANY SUBSEQUENT ACTION TAKEN/TO BE TAKEN.

a) Parish Leaflet - Work on this was progressing with publication due in December. At present awaiting bus time tables which will not be issued until the end of September.

Maps - two to be produced - one to be the centre of the village, the other of the whole parish showing footpaths. Further details to be given in November.

An O.S map to be purchased framed and hung in the Jubilee Hall - the Vice Chairman to deal with this.

b) Storage of deeds - these were now held by Milford and Dormer of Chard. The Clerk had photocopied deeds before they had been deposited.

The Band Hut deeds were handed over by the Vice Chairman, would also be photocopied then placed with Milford and Dormer.

c) Parish Council Notice Board - the chairman said he would make up the difference in cost on this. It would be in U.V.P.C. plastic and would be able to hold 4 A4 sheets. Blu tack would be needed to hold notices in place.

034 P.C. ROGER SAUNDERS.

P.C. Saunders had sent his apologies and there was no police report.

035 MR. D. ESP (County Councillor's Report)

Highway matters - most of the repairs in hand had been attended to. Parish councillor's felt that the work carried out was below standard. The clerk to write to Highways.

Drop kerbs by the school still need doing- the Clerk to mention this.

Loose material at top of flood prevention works needs to be removed.

The surfaces on many of the lanes leading into Winsham were in very poor condition, also hedges were growing across many of these roads. The clerk to also inform Highways.

036 Mrs. S. ABBEY (District Councillor's Report)

Adoption of Davies Close - residents would probably be required to contribute to bring it up to the standard for it to be adopted by the Council.

Parish Emergency Contacts are being drawn up - helpers names will be required.

West Issues Group had been attended by Mrs. Abbey - the Parish Council would be receiving some information to comment on.

Police Records - these only refer to beats - therefore making it difficult to relate to an area.

037 AMENITIES

c) Parish Paths Partnership

Mr. Dennis Shaw had offered to become the co-ordinator for this project.

The Parish Paths Partnership Agreement was signed and handed to Ms. Carmel Wilkinson. Work on various paths would be undertaken in phases.

Phrase one - Contractors had carried out work on the Liberty Trail. A new kissing gate to Western Way.

Footway to Badger Wood now has to have gates - this was to be carried out.

Mr. Shaw told Councillors that he hoped to create a village walk, this would be paid for by the Land Commissioners.

Cemetery Path - it was agreed to cut the path on a more regular basis across two of the fields.

Dog poo bags - a box of these to be held by the Post Office for the public to use.

The chairman thanked Mr. Shaw for becoming co-ordinator and Ms. Wilkinson for the help she had given.

Mr. D. Esp and Mrs. S. Abbey left the meeting at this point.

a) Concreting round manhole in rec. - this had been done.

b) Sign for NO BALL GAMES/NO DOGS in small rec. - this needs planning - an application form and a cheque for £25.00 were passed to Mr. Sullivan to deal with. It was agreed that the sign should be worded:

- c) Play Equipment the Chairman to remove swing that doesn't meet safety standards. The Chairman to find existing records regarding new equipment.
- d) Re-cycling Centre these were now in situ.
- f) Grass Cutting 1999 needs different level of service then the present contract which is for a cut every two weeks without the grass being collected. There is only one more cut for the current season.
- A decision to be made on the level of service for each area costings to be found out for October.
- g) Dog Bin siting of After much discussion it was agreed to site dog bin at the bottom of Pools Lane just off school playing field.

Street Lighting expert would be meeting Councillors at 8.00 on 3rd September to study where street lighting was most needed. A report on this in October.
