Minutes of the Winsham Parish Council Meeting on the 10th November 1995 in the Jubilee Hall at 8.00 P.M.

70. Apologies for absence.

Were received from Mr D Esp (Cty Cllr), Mrs E Jones and Mr K Fowler.

71. Public Question Time.

Mr Perrott said he had not been told that reburials would not take place in Winsham Cemetery.

Mr Slade said he had contacted Mr Bulivant and the price for the parcel of land in question was now £1500. If the Parish Council purchase the land Mr Bullivant will donate £500 to Winsham Church. Mr Slade is trying to contact Mr DeSavory, the owner of the other piece of land between the Cemetery Path and Western Way. Any price paid for land will probably mean about an extra £1000 for fencing and legal fees. All avenues will be pursued. A decision will be made at the December Meeting.

Mrs DeGroot said a Tree Dressing Day was organised on the 2nd and 3rd of December. Tables are required for persons to bring food. This will take place in the Small Recreation Ground.

Mrs Ann Bevis spoke on the proposed Play Equipment. A Committee will be formed. Mr K Fowler and Mrs H Duke will be the Parish Council representatives. Three plans and prices are required by the Parish Council before a donation can be provided.

72. Mr Phil Jones on Street Cleansing.

Mr Jones took over control of Street Cleansing on the 1st August 1995. He is in charge of complaints and hopes to sort out any problems. On weed killing, the weed killer which has to be used does not kill the roots of the plants.

The approach roads to the Village are to be cleaned every 6 Months. The Village Streets will be cleaned every 2 Months.

Litter Picking will take place every Month.

Weeds will be deal with 2 or 3 times a year.
